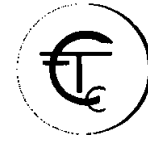

When sending by simple letter (§ 122 Abs. 2 Tax Code) or delivery by registered letter by handover (§ 4 Abs. 1 Verwaltungszustellungsgesetz) within the scope of the Tax Code and the Verwaltungszustellungsgesetzes the announcement with the third day after posting to the post office shall be deemed to have been effected unless the administrative act has not been received or at a later date. In the case of delivery by means of a deed of delivery, by registered letter with acknowledgment of receipt or against acknowledgment of receipt, the date of notification is the day of notification (§§ 3, 4 para. 2, 5 VwZG). 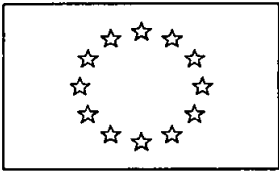

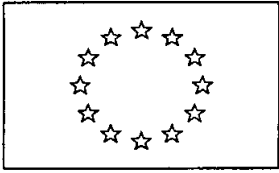

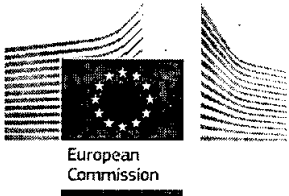
