GREEN LINE REGULATION (EC) NO. 866/2004 CROSSING OF GOODS THROUGH APPROVED CROSSING POINTS OF THE REPUBLIC OF CYPRUS

ITEMS PERMITTED FOR PERSONAL USE

- 40 CIGARETTES AND 1 LITRE OF ALCOHOL PER PERSON OVER THE AGE OF 17
- PURCHASES OF ITEMS NOT SUBJECT TO PROHIBITIONS AND RESTRICTIONS,
 VALUE UP TO €260
- SMALL QUANTITIES OF AGRICULTURAL PRODUCTS (UP TO 3 KG OR 3 BUNDLES)
- SMALL QUANTITIES OF THE FOLLOWING PROCESSED FOODS OF NON-ANIMAL ORIGIN SUCH AS OLIVE OIL, HALVA, JAMS, TABLE OLIVES (black and green) AND JUICES, NECTAR AND FRUIT DRINKS (Apple, Grapefruit, Pineapple, Cherry, Peach, Apricots, Orange and Pomegranate).

ITEMS THAT ARE PROHIBITED FROM CROSSING

- CIGARS AND CIGARILLOS
- TOBACCO FOR CIGARETTES AND TOBACCO FOR SHISHA
- HEATED TOBACCO PRODUCTS
- COUNTERFEITS/GOODS THAT INFRINGE INTELLECTUAL PROPERTY RIGHTS (EVEN ONE PIECE)
- FUEL
- MACHINE LUBRICANTS (MACHINE OILS)
- LIVE ANIMALS AND ANIMAL PRODUCTS (eg MEAT, MILK, FEATHERS, SKINS, ANIMAL FERTILIZER-MANURE, SNAILS, REPTILES, HUNTER'S GAME, etc.) FISH IS EXCEPTED FROM THE PROHIBITION, ONLY FOR COMMERCIAL TRAFFIC, WITH ACCOMPANYING DOCUMENT FROM THE TURKISH CYPRIOT CHAMBER OF COMMERCE.
- HONEY (NOT FOR COMMERCIAL OR PERSONAL USE)
- PLASTIC MATERIALS AND SINGLE-USE ITEMS INTENDED TO COME IN CONTACT WITH FOOD (cutlery, plates, straws, drink stirrers, etc.)
- DECORATIVE PLANTS (TREES, BUSHES, POTTED FLOWERS) AND CUT FLOWERS.
- FRUIT TREES
- TIMBER/FIREWOOD FROM CONIFEROUS TREES, PLATANIUM AND CHESTNUT -ALL OTHER TYPES OF WOOD (NOT FRESH BRANCHES/LEAVES/FRUITS) ARE ALLOWED FOR COMMERCIAL PURPOSES AND FOR PERSONAL USE UP TO 25 KG (Any transport of timber must be accompanied by ONE of the following documents:
 - Transport Permit from the Forestry Department (T.D. 203)
 - Transfer Certificate from a licensed firewood dealer (T.D. 224A)
 - Transfer Certificate from the President of the Community Council (T.D. 224B)

- SEEDS (FOR PLANTING)
- GRAPES, GRAPES FRUIT AND VINE PLANTS
- CITRUS FRUITS (FRUITS WITH LEAVES AND STEMS) AND CITRUS FRUITS ON A COMMERCIAL BASIS, <u>UNLESS ACCOMPANIED BY A PHYTOSANITARY</u> <u>CERTIFICATE</u>
- POTATOES ON A COMMERCIAL BASIS, <u>UNLESS ACCOMPANIED BY A PHYTOSANITARY CERTIFICATE</u>
- MEDICINES (SMALL QUANTITIES ALLOWED AFTER SELF-DECLARATION OF THE INTERESTED PARTY)
- NARCOTICS AND PSYCHOTROPIC SUBSTANCES, ANABOLIC STEROIDS FOR DOPING
- PESTICIDES
- ARMS, AMMUNITION, GUNS, FIRECRACKERS AND SIMILAR
- ANTIQUITIES

CASH MOVEMENTS - €10,000 AND ABOVE

PERSONS ENTERING FROM THE OCCUPIED TO THE FREE AREAS OF THE REPUBLIC OF CYPRUS AND ARE HAVING IN THEIR POSSESSION OR CARRYING AMOUNT OF €10,000 OR MORE OR THE EQUAL AMOUNT IN ANOTHER CURRENCY, MUST MAKE A DECLARATION IN WRITING TO THE CUSTOMS OFFICERS ON DUTY AT THE CROSSING POINT IN CASE THEY CARRIED ENTERING CYPRUS THROUGH THE CLOSED PORTS OR AIRPORTS SITUATED IN THE OCCUPIED AREAS.

ITEMS ALLOWED TO ENTER TEMPORARILY FOR PRIVATE USE BY ISSUING THE FORM CP5 (NOT FOR MORE THAN 6 MONTHS AND MUST BE RETURNED TO THE OCCUPIED AREAS NOT BEFORE THE EXPIRY DATE OF THE FORM CP5)

- VEHICLES WITH FOREIGN REGISTRATION NUMBERS
- PERSONAL EFFECTS GOODS FOR SPORTING PURPOSES (NO HUNTING GUNS, SHOOTING BOWS AND SIMILAR ITEMS)
- PROFESSIONAL EQUIPMENT
- GOODS FOR REPAIR
- GOODS FOR EXHIBITION
