## Notes

- 1. This declaration must be completed in Cyprus Pounds for years up to 2007 and Euro for years from 2008.
- Individuals who are entitled to interest on deposits and whose total income, including interest, is less than £7.000 for year up to 2007 and less than €12.000 for years from 2008 onwards, have the right to a refund of Special Contribution for Defence that has been withheld in excess of 3%.
- 3. The Income Declaration for the Refund of Special Contribution for Defence withheld from Interest on Deposits must be completed ONLY by Cyprus residents and who are: Pensioners, Employees, House Wives, Students and Soldiers. Individuals under the age of 18 are considered dependants of other persons and any income that they have must be included in the tax return of the donor. Tax payer's that belong to any other category must complete the Income Tax Return I.R.1A.
- 4. Cyprus Residents are those individuals who remain in Cyprus, for one or more periods, exceeding in aggregate 183 days in a tax year.
- 5. Personal Identification is any of the following official documentation with which an individuals identity can be certified. Such identification must ONLY be given if there is no Cyprus Identity Card Number. The Personal Identification consists of a Greek character and a number as indicated below. In Section 1,4 complete the Greek character and the number of the Personal Identification. Attach a photocopy of the Personal Identification with this declaration.

- 6. If you have more than one bank account please attach a summary with all the necessary details and enter the total amounts in parts 3 and 4.
- Pensioners, whose only income is from pension and interest from deposits, ONLY from common account/s with his/her spouse whose only income is also only from pension and interest, may submit a common Income Tax return (I.R.1EEA A) 2012, by completing Part 4 -SPOUSES' DETAILS and signing Part 6 of the Return.
- 8 Income Declaration (Form I.R.1EEA A) 2012, must be submitted to the Management of Returns Section of the Inland Revenue Department of your District, together with the original interest withheld certificate and a photocopy of your Identity Care or your Personal Identification. The interest withheld certificate must contain the gross interest and the amount of Special Contribution for Defence withheld.
