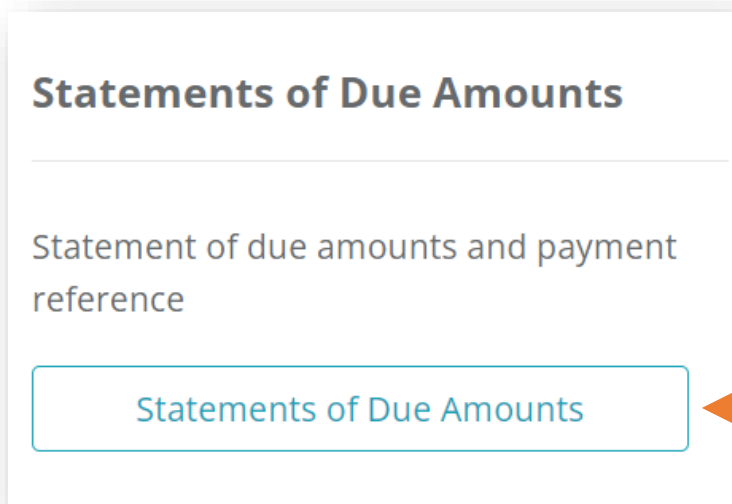

4. Choose “Statement of Due Amounts” to view any taxes due resulting from:

(a) the imposition of assessments by the Tax Department or


(b) the final submission of tax returns via the TAXISnet system or

(c) your entry of self-assessments to the TAXPORTAL



5. Select (double click) the tax category/kind (i.e. income tax, defense tax, gesy) to get a **detailed analysis** of the tax due.
