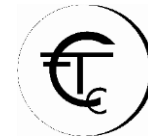

### **Additional information for the application form C.1000**

- In Customs Registry persons registered according to the article 119 of The Customs Code Law of 2004 94(I)/2004 as well as according to KDP 443/2004.
- EORI number is given according to Regulation (EU) number 2013/952.
- Customs and Excise Department after the acceptance and the approval of the application gives a single registration number to the Customs Registry and EORI Database.
- For natural persons the completed application form C.1000 must be accompanied by:
  - ❖ Applicants ID or passport for verification of the identity of the person signing
  - ❖ Copy of the traders name certificate from the Registrar of Companies, if any
  - ❖ Copy of the VAT registration certificate, if any
  - ❖ Stamp, if any
- For legal persons the completed application form C.1000 must be accompanied by:
  - ❖ Copies for all Registrar of Companies certificates (incorporation, office of establishment, directors etc)
  - ❖ Directors/Secretary ID or passport for verification of the identity of the person signing
  - ❖ Copy of the VAT registration certificate, if any
  - ❖ Company stamp, if any
- For associations, foundations, embassies etc the completed application form C.1000 must be accompanied by:
  - ❖ Copies for all documents for the establishment of the association, foundation etc
  - ❖ Letter or certificate that proves that the person signing the application is authorised to do so
  - ❖ Authorised person's ID or passport for verification of the identity of the person signing
  - ❖ Association, foundation, embassy etc stamp

### **Explanatory notes**

- <sup>1</sup> Identification number or numbers assigned to the person concerned for customs purposes by the Competent Authorities of a third country with which an Agreement on Mutual Assistance in Customs matters is in force.
- <sup>2</sup> Person that will undertake any obligations coming from the National or Community legislation.
- <sup>3</sup> For the purposes of par. 2, associated registrations of legal or natural persons are considered those when:
  - I. officers or members of the board of directors for the one person are at the same time officers or members of the board of directors for the other.
  - II. together they control, directly or indirectly, a third person.
  - III. they are controlled directly or indirectly by a third person.
  - IV. one of them has under control, directly or indirectly, the other.
  - V. a legal partnership exists between them.
  - VI. an employer - employee relationship exists.
  - VII. in the case of physical persons, they are members of the same family.
  - VIII. the one person occupies, directly or indirectly, 5% or more of the shares, with voting rights, of the one or the other person.

- <sup>6</sup> E.U. has a Database for Economic Operators and other persons registered in EORI System. This Database is on the internet and is accessible to the public in order to verify the validity of EORI numbers. In the case where Economic Operators consent to disclosure of their details, that information will be disclose on the internet. - <sup>7</sup> Signing the application must be done in the presence of a customs officer during the submission of the application or must be verified by a certifying officer or other Proper Authority for verification of signatures, duly stamped with the relevant revenue stamps. Note that in the case where a third person is authorized to sign the application in the presence of a customs officer, the authorisation must be properly certified and duly stamped.
