

Interpretation	<p>3. (1) In this decree, unless the context otherwise requires, the following terms shall have the meaning ascribed to them hereunder:</p> <p>“dormant account” is an account (other than an annuity contract) if:</p> <ul style="list-style-type: none"> (a) the account holder has not initiated a transaction with regard to the account or any other account held by the account holder with the Reporting Cyprus Financial Institution in the previous three years; (b) the account holder has not communicated with the Reporting Cyprus Financial Institution that maintains such account in relation to the account or any other account held by the account holder with the Reporting Cyprus Financial Institution in the past six years; and (c) in the case of a Cash Value Insurance Contract, the Reporting Cyprus Financial Institution has not communicated with the account holder that holds such account regarding the account or any other account held by the account holder with the Reporting Cyprus Financial Institution in the past six years; <p>Alternatively, an account may also be considered as a dormant account when the Reporting Cyprus Financial Institution treats the account as a dormant account under its normal operating procedures that are consistently applied for all accounts maintained by such institution in Cyprus, provided that such procedures contain substantially similar requirements to those in Section (a) to (c).</p> <p>“foreign state” shall mean any member state or any country other than the member state or country where the Reporting Cyprus Financial Institution is located;</p> <p>“Cash Value” shall mean the greater of:</p> <ul style="list-style-type: none"> (a) the amount that the policy holder is entitled to receive upon surrender or termination of the contract (determined without reduction for any surrender charge or loan granted under the insurance policy), and (b) the amount the policy holder can borrow under or with regard to the contract. <p>Notwithstanding the foregoing, the term “Cash Value” does not include amounts payable under an Insurance Contract:</p> <ul style="list-style-type: none"> (i) solely by reason of the death of an individual insured under a life insurance contract; (ii) as a personal injury or sickness benefit or other benefit providing indemnification of an economic loss incurred upon the occurrence of an event covered by the insurance; (iii) as a refund of a previously paid premium (less cost of insurance charges whether or not actually imposed) under an Insurance Contract (other than an investment-linked life insurance or annuity contract) due to cancellation or termination of the contract, decrease in risk exposure during the effective period of the contract, or arising from the correction of an entry or similar error with regard to the premium paid for the contract; (iv) as a policy holder dividend (other than a termination dividend) provided that the dividend relates to an Insurance Contract under which the only benefits payable are

In addition, a change in circumstances includes any change or addition of information to the account holder’s account (including the addition, substitution, or other change of an account holder) or any change or addition of information to any account associated with such account (applying the account aggregation rules the rules set forth in section 30, if such change or addition of information affects the status of the account holder.</p> <p>“Exempt Collective Investment Vehicle” means any Investment Entity that is regulated as a collective investment vehicle, provided that all of the interests in the collective investment vehicle are held by or through individuals or Entities that are not Reportable Persons, save for Passive NFEs with Controlling Persons who are Reportable Persons.</p> <p>“Competent Authority” shall mean the Minister of Finance or a person appointed by him.</p> <p>“Cash Value Insurance Contract” shall mean an insurance contract (other than an indemnity reinsurance contract between two insurance companies) that has Cash Value.</p> <p>“Insurance Contract” means a contract (other than an Annuity Contract) under which the issuer agrees to pay an amount upon the occurrence of a specified contingency involving mortality, morbidity, accident, liability, or property related risk.</p> <p>“Self-Certification” means a certification by the account holder that determines the account holder’s status and any other information that may be reasonably requested by the Reporting Cyprus Financial Institution to fulfil its reporting and due diligence obligations, such as whether the account holder is resident for tax purposes in a Reportable Jurisdiction.</p> <p>“TIN” means the Taxpayer Identification Number. In the absence of a TIN a functional equivalent unique identifier can be used to identify the individual or an Entity for purposes of administering the tax laws of the foreign jurisdiction.</p> <p>“AML/KYC Procedures” means the customer due diligence procedures which such Reporting Financial Institution is obliged to apply pursuant to the Prevention and Suppression of Money Laundering Law, as is in force or amended from time to time.</p> <p>“Account Holder” means the person listed or identified as the holder of a Financial Account by the Financial Institution that maintains the account.</p> <p>It is provided that, a person, other than a Financial Institution, holding a Financial Account for the benefit or account of another person as agent, custodian, nominee, signatory, investment advisor, or intermediary, other than a third person acting as an intermediary as stipulated in section 7 below, is not treated as holding the account for purposes of the CRS, and such other person is treated as holding the account.</p> <p>It is further provided that, in the case of a Cash Value Insurance Contract or an Annuity Contract, the account holder is any person entitled to collect the Cash Value or change the beneficiary of the contract.</p> <p>It is further provided that, if no person is entitled to collect the Cash Value or change the</p>

beneficiary, the account holder is any person named as the owner in the contract and any person with a vested entitlement to payment under the terms of the contract. Upon the maturity of a Cash Value Insurance Contract or an Annuity Contract, each person entitled to receive a payment under the contract is treated as an account holder.

“International Organisation” means any international organisation or wholly owned agency or instrumentality thereof. This category includes any intergovernmental organization (including supranational organizations):

- (a) that is comprised primarily of governments;
- (b) that has in effect a headquarters or substantially similar agreement with the jurisdiction; and
- (c) the income of which does not inure to the benefit of private persons.

“Reportable Jurisdiction” means a jurisdiction:

- (a) with which an agreement is in place pursuant to which there is an obligation in place to provide the information specified in paragraph 9 of this decree, and
- (b) which is identified in the official website of the Tax Department of the Ministry of Finance.

“Reportable Account” means an account held with a Reporting Cyprus Financial Institution by one or more Reportable Persons or by a Passive Non-Financial Entity with one or more Controlling Persons being Reportable Persons, provided it has been identified as such, pursuant to the due diligence procedures set forth in this Decree.

“Cyprus Financial Institution” means (i) any Financial Institution resident in Cyprus, but excluding any branch of such Financial Institution that is located outside Cyprus and (ii) any branch of a Financial Institution not resident in Cyprus, if such branch is located in Cyprus.

“Reporting Cyprus Financial Institution” means a Cyprus Financial Institution that is not a Non-Reporting Cyprus Financial Institution.

“Reportable Person” means a Reportable Jurisdiction Person other than:

- (a) a corporation the stock of which is regularly traded on one or more established securities markets;
- (b) any corporation that is a Related Entity of a corporation described in clause (a);
- (c) a Governmental Entity;
- (d) an International Organization;
- (e) a Central Bank; or
- (f) a Financial Institution.

“Reportable Jurisdiction Person” means an individual or Entity that is resident in a Reportable Jurisdiction under the tax laws of such jurisdiction, or an estate of a decedent that was a resident of a Reportable Jurisdiction.

For this purpose, an Entity such as a partnership, limited liability partnership or similar legal arrangement that has no residence for tax purposes shall be treated as resident in the jurisdiction in which its place of effective management is situated.

“Active NFE” means any NFE that meets any of the following criteria:

(a) less than 50% of the NFE’s gross income for the preceding calendar year or other appropriate reporting period is passive income and less than 50% of the assets held by the NFE during the preceding calendar year or other appropriate reporting period are assets that produce or are held for the production of passive income;

(b) the stock of the NFE is regularly traded on an established securities market or the NFE is a Related Entity of an Entity the stock of which is regularly traded on an established securities market;

(c) the NFE is a Governmental Entity, an International Organisation, a Central Bank, or an Entity wholly owned by one or more of the foregoing;

(d) substantially all of the activities of the NFE consist of holding (in whole or in part) the outstanding stock of, or providing financing and services to, one or more subsidiaries that engage in trades or businesses other than the business of a Financial Institution, except that an Entity does not qualify for this status if the Entity functions (or holds itself out) as an investment fund, such as a private equity fund, venture capital fund, leveraged buyout fund, or any investment vehicle whose purpose is to acquire or fund companies and then hold interests in those companies as capital assets for investment purposes;

(e) the NFE is not yet operating a business and has no prior operating history, but is investing capital into assets with the intent to operate a business other than that of a Financial Institution, provided that the NFE does not qualify for this exception after the date that is 24 months after the date of the initial organisation of the NFE;

(f) the NFE was not a Financial Institution in the past five years, and is in the process of liquidating its assets or is reorganising with the intent to continue or recommence operations in a business other than that of a Financial Institution;

(g) the NFE primarily engages in financing and hedging transactions with, or for, Related Entities that are not Financial Institutions, and does not provide financing or hedging services to any Entity that is not a Related Entity, provided that the group of any such Related Entities is primarily engaged in a business other than that of a Financial Institution; or

(h) the NFE meets all of the following requirements:

(i) it is established and operated in its jurisdiction of residence exclusively for religious, charitable, scientific, artistic, cultural, athletic, or educational purposes; or it is established and operated in its jurisdiction of residence and it is a professional organisation, business league, chamber of commerce, labour organisation, agricultural or horticultural organisation, civil league or an organisation operated exclusively for the promotion of social welfare;

(ii) it is exempt from income tax in its jurisdiction of residence;

(iii) it has no shareholders or members who have a proprietary or beneficial interest in its income or assets;

(iv) the applicable laws of the NFE’s jurisdiction of residence or the NFE’s formation documents do not permit any income or assets of the NFE to be distributed to, or applied for the benefit of, a private person or non-charitable Entity other than pursuant to the conduct of the NFE’s charitable activities, or as payment of reasonable compensation for services rendered, or as payment representing the fair market value of property, which the NFE has purchased; and

(v) the applicable laws of the NFE's jurisdiction of residence or the NFE's formation documents require that, upon the NFE's liquidation or dissolution, all of its assets be distributed to a Governmental Entity or other non-profit organisation, or escheat to the government of the NFE's jurisdiction of residence or any political subdivision thereof.

"Excluded Account" means any of the following accounts:

(a) a retirement or pension account that satisfies the following requirements:

i) the account is subject to regulation as a personal retirement account or is part of a registered or regulated retirement or pension plan for the provision of retirement or pension benefits (including disability or death benefits);

ii) the account is tax-favoured (i.e. contributions to the account that would otherwise be subject to tax are deductible or excluded from the gross income of the account holder or taxed at a reduced rate, or taxation of investment income from the account is deferred or taxed at a reduced rate);

iii) information reporting is required to the tax authorities with respect to the account;

iv) withdrawals are conditioned on reaching a specified retirement age, disability, or death, or penalties apply to withdrawals made before such specified events; and

v) either annual contributions are limited to USD fifty thousand (50,000) or less, or there is a maximum lifetime contribution limit to the account of USD one million (1,000,000) or less, in each case applying the rules set forth in Sections 30 and 31 for account aggregation and currency translation:

It is provided that, a Financial Account that otherwise satisfies the requirement of subparagraph (i) of paragraph (v) of section (a) above will not fail to satisfy such requirement solely because such Financial Account may receive assets or funds transferred from one or more Financial Accounts that meet the requirements of subparagraph (a) or (b) from one or more retirement or pension funds that meet the requirements of any of Broad Participation Retirement Fund, or Narrow Participation Retirement Fund or Pension Fund of a Governmental Entity, International Organisation or Central Bank.

b) an account that satisfies the following requirements:

i) the account is subject to regulation as an investment vehicle for purposes other than for retirement and is regularly traded on an established securities market, or the account is subject to regulation as a savings vehicle for purposes other than for retirement;

ii) the account is tax-favoured (i.e. contributions to the account that would otherwise be subject to tax are deductible or excluded from the gross income of the account holder or taxed at a reduced rate, or taxation of investment income from the account is deferred or taxed at a reduced rate);

iii) withdrawals are conditioned on meeting specific criteria related to the purpose of the investment or savings account (for example, the provision of educational or medical benefits), or penalties apply to withdrawals made before such criteria are met; and

iv) annual contributions are equal to the amount translated into the local currency

of each Jurisdiction corresponding to US\$ fifty thousand (50,000) or less, applying the rules set forth in section 30 and 31 for account aggregation and currency translation.

It is provided that, a Financial Account that otherwise satisfies the requirement of subparagraph (b)(iv) will not fail to satisfy such requirement solely because such Financial Account may receive assets or funds transferred from one or more Financial Accounts that meet the requirements of subparagraph (a) or (b) above or from one or more retirement or pension funds that meet the requirements of any of Broad Participation Retirement Fund, or Narrow Participation Retirement Fund or Pension Fund of a Governmental Entity, International Organisation or Central Bank.

c) a life insurance contract with a coverage period that will end before the insured individual attains age 90, provided that the contract satisfies the following requirements:

i) periodic premiums, which do not decrease over time, are payable at least annually during the period the contract is in existence or until the insured attains age 90, whichever is shorter;

ii) the contract has no contract value that any person can access (by withdrawal, loan, or otherwise) without terminating the contract;

iii) the amount (other than a death benefit) payable upon cancellation or termination of the contract, cannot exceed the aggregate premiums paid for the contract, less the sum of mortality, morbidity, and expense charges (whether or not actually imposed) for the period or periods of the contract's existence and any amounts paid prior to the cancellation or termination of the contract; and

iv) the contract is not held by a transferee for value.

d) An account belonging solely to inheritance, if the documents in the account include a copy of the mourning testament or death certificate

e) an account established in connection with any of the following:

i) a court order or judgment.

ii) a sale, exchange, or lease of real or personal property, provided that the account satisfies the following requirements:

(i) the account is funded solely with a down payment, earnest money, deposit in an amount appropriate to secure an obligation directly related to the transaction, or a similar payment, or is funded with a Financial Asset that is deposited in the account in connection with the sale, exchange, or lease of the property;

(ii) the account is established and used solely to secure the obligation of the purchaser to pay the purchase price for the property, the seller to pay any contingent liability, or the lessor or lessee to pay for any damages relating to the leased property as agreed under the lease;

(iii) the assets of the account, including the income earned thereon, will be paid or otherwise distributed for the benefit of the purchaser, seller, lessor, or lessee (including to satisfy such person's obligation) when the property is sold, exchanged, or surrendered, or the lease terminates;

(iv) the account is not a margin or similar account established in connection with a

	<p>sale or exchange of a Financial Asset; and</p> <p>(v) the account is not associated with an account described in subparagraph (f) below.</p> <p>iii) an obligation of a Financial Institution servicing a loan secured by real property to set aside a portion of a payment solely to facilitate the payment of taxes or insurance related to the real property at a later time;</p> <p>iv) an obligation of a Financial Institution solely to facilitate the payment of taxes at a later time.</p> <p>f) a Depository Account that satisfies the following requirements:</p> <p style="padding-left: 40px;">i) the account exists solely because a customer makes a payment in excess of a balance due with respect to a credit card or other revolving credit facility and the overpayment is not immediately returned to the customer; and</p> <p style="padding-left: 40px;">ii) beginning on or before 1/1/2016, the Financial Institution implements policies and procedures either to prevent a customer from making an overpayment in excess of US\$ fifty thousand (50,000), or to ensure that any customer overpayment in excess of US\$ fifty thousand (50,000) is refunded to the customer within 60 days, in each case applying the rules set forth in section 31 for currency translation:</p> <p style="padding-left: 80px;">It is provided for the purpose of this sub-paragraph that a customer overpayment does not refer to credit balances to the extent those are relating to disputed charges, but does include credit balances resulting from merchandise returns.</p> <p>g)(i) a preexisting account (other than an Annuity Contract) with an annual balance that does not exceed USD 1000, that is a dormant account in accordance with the definition provided in the commentary on Section III of the Common Reporting Standard.</p> <p>(ii) any other account that presents a low risk of being used to evade tax, has substantially similar characteristics to any of the accounts described in subparagraphs (a)-(f) above, and is defined in domestic law as an Excluded Account, provided that the status of such account as an Excluded Account does not frustrate the purposes of the Common Reporting Standard.</p> <p>“Investment Entity” means any Entity:</p> <p>(a) that primarily conducts as a business one or more of the following activities or operations for or on behalf of a customer:</p> <p style="padding-left: 40px;">i) trading in money market instruments (cheques, bills certificates of deposit, derivatives, etc), foreign exchange; exchange, interest rate and index instruments; transferable securities; or commodity futures trading;</p> <p style="padding-left: 40px;">ii) individual and collective portfolio management; or</p> <p style="padding-left: 40px;">iii) otherwise investing, administering, or managing Financial Assets or money on behalf of other persons; or</p> <p>(b) the gross income of which is primarily attributable to investing, reinvesting, or trading in Financial Assets, if the Entity is managed by another Entity that is a Depository Institution, a</p>

Custodial Institution, a Specified Insurance Company, or an Investment Entity described under paragraph (a):

It is provided that, an Entity is treated as primarily conducting as a business one or more of the activities described in subparagraph (a) above, or an Entity's gross income is primarily attributable to investing, reinvesting, or trading in Financial Assets for purposes of the current subparagraph, if the Entity's gross income attributable to the relevant activities equals or exceeds 50% of the Entity's gross income during the shorter of:

(i) the three-year period ending on 31 December of the year preceding the year in which the determination is made; or

(ii) the period during which the Entity has been in existence.

(c) The term "Investment Entity" does not include an Entity that is an Active NFE according to the subparagraphs (d)-(g).

It is provided that the present paragraph shall be construed in accordance with the definition of the term "Financial Institution" in the Financial Action Task Force Recommendations.

"Custodial Institution" means any Entity that holds, as a substantial portion of its business, Financial Assets for the account of others. An Entity holds Financial Assets for the account of others as a substantial portion of its business if the Entity's gross income attributable to the holding of Financial Assets and related financial services equals or exceeds 20% of the Entity's gross income during the shorter of:

(a) the three-year period that ends on 31 December (or the final day of a non-calendar annual accounting period) prior to the year in which the determination is being made; or

(b) the period during which the Entity has been in existence.

"Depository Institution" means any Entity that accepts deposits in the ordinary course of a banking or similar business.

"Specific Insurance Company" shall mean every Entity that is an insurance company (or a holding company of an insurance company) offering Cash Value Insurance Contracts of Annuity Contracts or which is obliged to effect payments pursuant to such contracts.

"Participating Jurisdiction Published List" means a published list which includes all participating and reportable jurisdictions.

"Governmental Entity" means the government of a jurisdiction, any political subdivision of a jurisdiction (which for the avoidance of doubt, includes a state, province, county or municipality), or any wholly owned agency or instrumentality of a jurisdiction or of any one or more of the foregoing (each, a "Government Entity"). This category is comprised of the integral parts, controlled entities, and political subdivisions of a jurisdiction.

An "integral part" of a jurisdiction means any person, organisation, agency, bureau, fund, instrumentality, or other body, however designated, that constitutes a governing authority of a jurisdiction. The net earnings of the governing authority must be credited to its own account or to other accounts of the jurisdiction, with no portion inuring to the benefit of any private person. An integral part does not include any individual who is a sovereign, official, or administrator acting in a private or personal capacity.

It is further provided that a controlled entity includes an Entity that is separate in form from the jurisdiction or that otherwise constitutes a separate juridical entity, provided that:

i) the Entity is wholly owned and controlled by one or more Governmental Entities directly or through one or more controlled entities;

ii) the Entity's net earnings are credited to its own account or to the accounts of one or more Governmental Entities, with no portion of its income inuring to the benefit of any private person; and

iii) the Entity's assets vest in one or more Governmental Entities upon dissolution.

Income does not inure to the benefit of private persons if such persons are the intended beneficiaries of a governmental programme, and the programme activities are performed for the general public with respect to the common welfare or relate to the administration of some phase of government. Notwithstanding the foregoing, however, income is considered to inure to the benefit of private persons if the income is derived from the use of a governmental entity to conduct a commercial business, such as a commercial banking business, that provides financial services to private persons.

"Central Bank" means the Central Bank of Cyprus or the Central Bank of other Jurisdictions.

"Custodial Account" means an account (other than an Insurance Contract or Annuity Contract) that holds one or more Financial Assets for the benefit of another person.

Depository Account includes any commercial, checking, savings, time, or thrift account, or an account that is evidenced by a certificate of deposit, thrift certificate, investment certificate, certificate of indebtedness, or other similar instrument maintained by a Financial Institution in the ordinary course of a banking or similar business. A Depository Account also includes an amount held by an insurance company pursuant to a guaranteed investment contract or similar agreement to pay or credit interest thereon.

Equity interest means, in the case of partnership that is a Financial Institution, either a capital or profits interest in the partnership. In the case of a trust that is a Financial Institution, an Equity Interest is considered to be held by any person treated as a settlor or beneficiary of all or a portion of the trust, or any other natural person exercising ultimate effective control over the trust. A Reportable Person will be treated as being a beneficiary of a trust if such Reportable Person has the right to receive directly or indirectly (for example, through a nominee) a mandatory distribution or may receive, directly or indirectly, a discretionary distribution of a trust.

"A Low Value Account" is a Pre-existing Individual Account with a balance or value as of 31 December 2015 that does not exceed US one million (\$1,000,000).

"A High Value Account" is a Pre-existing Individual Account with an aggregate balance or value that exceeds US one million (\$1,000,000) as of 31 December 2015 or 31 December of any subsequent year.

"NFE" means any Entity that is not a Financial Institution.

"Non Reporting Cyprus Financial Institution" means any Financial Institution that is:

(a) A Governmental Entity, International Organisation or Central Bank, other than with respect to a payment that is derived from an obligation held in connection with a commercial financial activity of a type engaged in by a Specific Insurance Company, Custodial Institution, or Depository Institution;

(b) a Broad Participation Retirement Fund; a Narrow Participation Retirement Fund, a Pension Fund of a governmental Entity, International Organisation or Central Bank; or a

	<p>Qualified Credit Card Issuer;</p> <p>(c) any other Entity that presents a low risk of being used to evade tax, has substantially similar characteristics to any of the Entities described in subparagraphs (a) and (b) above of the decree, and is defined in domestic law as a Non Reporting Financial Institution, provided that the status of such Entity as a Non reporting Financial Institution does not frustrate the purposes of the Common Reporting Standard;</p> <p>(d) an Exempt Collective Investment Vehicle; or</p> <p>(e) a trust to the extent that the trustee of the trust is a Reporting Financial Institution and reports all information required to be reported pursuant to section 1 of the MCAA with respect to all Reportable Accounts of the trust.</p> <p>“New Account” means a Financial Account maintained by a Reporting Financial Institution opened on or after 01 January 2016.</p> <p>“Law” means the Assessment and Collection of Taxes Law of 1978 to 2015 (Cap.2) as amended or replaced from time to time.</p> <p>“Group Cash Value Insurance Contract” means an Insurance Contract that has Cash Value which (i) covers individuals that are linked by their employer, commercial union, syndic organization or other union or group and (ii) charge a premium for each member of the group (or member of a category within the group) which is determined without taking into account all personal health characteristics save for age, sex, and smoking habits of the member (or of the category of members) of the group.</p> <p>“Group Annuity Contract” means an Annuity Contract pursuant to which the lenders are persons linked by their employer, commercial union, syndic organization or other union or group.</p> <p>“Entity” means a legal person or a legal arrangement, such as a corporation, partnership, trust, or foundation.</p> <p>“Passive NFE” means any:</p> <p>(i) NFE that is not an Active NFE; or</p> <p>(ii) an Investment Entity as described under sub-paragraph (b) of the definition of Investment Entity, that is not a Participating Jurisdiction Financial Institution.</p> <p>“Reportable Jurisdiction Person” means an individual or Entity that is resident in a Reportable Jurisdiction under the tax laws of such jurisdiction, or an estate of a decedent that was a resident of a Reportable Jurisdiction. For this purpose, an Entity such as a partnership, limited liability partnership or similar legal arrangement that has no residence for tax purposes shall be treated as resident in the jurisdiction in which its place of effective management is situated.</p> <p>“Controlling persons” means: The natural persons who exercise control over the Entity. In the case of a trust, such term means the settlor(s),the trustee(s),the protector(s)(if any),the beneficiary(ies) or class(es) of beneficiaries, and any other natural person(s) exercising ultimate effective control over the trust, and in case of a legal arrangement other than a trust, such term means persons in equivalent or similar positions. The term “Controlling persons” must be interpreted in a manner consistent with the Financial Action Task Force Recommendations.</p> <p>“Pre-existing Entity Account” means a Pre-existing Account held by one or more Entities.</p>

“Pre-existing Natural Person Account” means a Pre-existing Account held by one or more Natural Persons.

“Pre Existing Account” means:

(a) A Financial Account maintained by a Reporting Cyprus Financial Institution as of 31 December 2015.

(b) Any Financial Account of an Account Holder, regardless of the date such a Financial Account was opened if:

i) The Account Holder also holds with the Reporting Cyprus Financial Institution (or with a related Entity within the same jurisdiction as the Reporting Cyprus Financial Institution) a Financial account under subparagraph (a);

ii) The Reporting Cyprus Financial Institution (and, as applicable, the Related Entity within the same jurisdiction as the Reporting Cyprus Financial Institution) treats both the aforementioned Financial Accounts, and any other Financial Accounts of the Account Holder that are treated as Pre-existing Accounts under the subparagraph (a), as a single Financial Account for purposes of satisfying the standards of knowledge requirements and for purposes of determining the balance or value of any of the Financial Accounts when applying any of the account thresholds;

iii) With respect to a Financial Account that is subject to AML/KYC Procedures, the Reporting Cyprus Financial Institution is permitted to satisfy such AML/KYC Procedures for the Financial Account by relying upon the AML/KYC Procedures performed for the Pre-existing Account; and

iv) The opening of the Financial Account does not require the provision of new additional or amended customer information by the Account Holder other than for purposes of the Common Reporting Standard.

“Annuity Contract” means a contract under which the issuer agrees to make payments for a period of time determined in whole or in part by reference to the life expectancy of one or more individuals. The term also includes a contract that is considered to be an Annuity Contract in accordance with the law, regulation, or practice of the jurisdiction in which the contract was issued, and under which the issuer agrees to make payments for a term of years;

“Agreement” means the Multilateral Agreement of Competent Authorities for the automatic exchange of financial account information.

“Broad Participation Retirement Fund” means a fund established to provide retirement, disability, or death benefits, or any combination thereof, to beneficiaries that are current or former employees (or persons designated by such employees) of one or more employers in consideration for services rendered, provided that the fund:

(a) does not have a single beneficiary with a right to more than 5% of the fund’s assets;

(b) is subject to government regulation and provides information reporting to the tax authorities; and

(c) satisfies at least one of the following requirements:

(i) the fund is generally exempt from tax on investment income, or taxation of such income is deferred or taxed at a reduced rate, due to its status as a

"Pension Fund of a Governmental Entity, International Organisation or Central Bank" means a fund established by a Governmental Entity, International Organisation or Central Bank to provide retirement, disability, or death benefits to beneficiaries or participants that are current or former employees (or persons designated by such employees), or that are not current or former employees, if the benefits provided to such beneficiaries or participants are in consideration of personal services performed for the Governmental Entity, International Organisation or Central Bank.

"Participating Jurisdiction" means a jurisdiction (a) with which an agreement is in place pursuant to which it will provide information specified in paragraph 9 and (b) which is identified in a published list.

"Standardised industry coding system" means a coding system used to classify establishments by business type for purposes other than tax purposes.

"Branch" shall mean a unit, business or office of a financial institution classified as a branch under the regulatory regime of the reporting jurisdiction or as otherwise regulated pursuant to the laws of the reporting jurisdiction as being separate from the remaining offices, units or branches of said financial institution.

"Financial Account" means an account maintained by a Financial Institution, and includes a Depository Account, a Custodial Account and:

(a) in the case of an Investment Entity, any equity or debt interest in the Financial Institution:

Notwithstanding the foregoing, the term "Financial Account" does not include any equity or debt interest in an Entity that is an Investment Entity solely because it renders investment advice to, and acts on behalf of, a customer, or manages portfolios for, and acts on behalf of, a customer for the purpose of investing, managing, or administering Financial Assets deposited in the name of the customer with a Financial Institution other than such Entity;

(b) in the case of a Financial Institution not described in subparagraph (a) above, any participation or debt interest in the Financial Institution, if the class of interests was established with a purpose of avoiding reporting in accordance with Section 9; and

(c) any Cash Value Insurance Contract or any Annuity Contract offered or maintained by a Financial Institution, other than a noninvestment-linked, non-transferable immediate life annuity that is issued to an individual and monetises a pension or disability benefit provided under an account that is an Excluded Account. The term 'Financial Account' does not include any account that is an Excluded Account.

"Financial Asset" includes a security (for example, a share of stock in a corporation; partnership or beneficial ownership interest in a widely held or publicly traded partnership or trust; note, bond, debenture, or other evidence of indebtedness), partnership interest, commodity, swap (such as interest rate swaps, currency swaps, basis swaps, interest rate caps, interest rate floors, commodity swaps, equity swaps, equity index swaps, and similar agreements), Insurance Contract or Annuity Contract, or any interest (including futures

contracts, forward contracts or related options) in a security, partnership interest, commodity, swap, Insurance Contract, or Annuity Contract.

The term “Financial Asset” does not include a non-debt, direct interest in real property.

“Financial Institution” means a Custodial Institution, a Depository Institution, an Investment Entity, or a Specified Insurance Company.

“Participating Jurisdiction Financial Institution” means any Financial Institution that is Resident in a Participating Jurisdiction but excludes any branch of that Financial Institution that is located outside such Participating Jurisdiction, and any branch of a Financial Institution that is not Resident in a Participating Jurisdiction if that branch is located in such Participating Jurisdiction.

“Hold mail” instruction means a current instruction by the Account Holder, or an agent of the Account Holder, to keep the Account Holder’s mail until such instruction is amended.

“Qualified Credit Card Issuer means a Financial Institution satisfying the following requirements:

(a)The Financial Institution is a Financial Institution solely because it is an issuer of credit cards that accepts deposits only when a customer makes a payment in excess of a balance due with respect to the card and the overpayment is not immediately returned to the customer; and

(b)beginning on or before(01/01/2016),the Financial Institution implements policies and procedures either to prevent a customer from making an overpayment in excess of USD 50000,or to ensure that any customer overpayment in excess of USD 50000 is refunded to the customer within 60 days, in each case applying the rules set forth in paragraphs 30 and 31 of this decree for account aggregation and currency translation. For this purpose, a customer overpayment does not refer to credit balances to the extent of disputed charges but does not include credit balances resulting from merchandise returns.

Documentary evidence includes any of the following:

a)certificate of residence issued by an authorised government body(for example, a government or agency thereof, or a municipality) of the jurisdiction in which the payee claims to be resident.

b) with respect to an individual, any valid identification issued by an authorised government body(for example ,a government or agency thereof, or a municipality), that includes the individual’s name and is typically used for identification purposes.

c) with respect to an Entity, any official documentation issued by an authorised government body(for example, a government or agency thereof, or a municipality) that includes the name of the Entity and either the address of its principal office in the jurisdiction in which it claims to be resident or the jurisdiction in which the Entity was incorporated or organized.

d) any audited financial statement, third –party credit report, bankruptcy filing, or securities regulator’s report.
